

Other Provisions in 2014 HUD Appropriations Bill

\$130M for tenant protection vouchers; increase of \$55M; important for 2nd component of RAD

2015: Administration's proposal would increase to \$150M.

Extends 2nd component of RAD (RAP/Rent Supp) until December 31, 2014.

Authorizes 1 year extensions of expiring RAP/Rent Supp contracts

\$5M for tenant protection vouchers or PBVs for certain properties in low vacancy areas, i.e., maturing non-profit 236/221(d)(3).

• 2015: Administration's proposal for 2015 is also \$5M.

Owners to remit residual receipts on "new reg" Section 8 contracts to HUD.













Other Provisions in 2014 HUD Appropriations Bill (cont'd)

Allows for transfer of Section 8 contracts and/or Use Agreements between properties.

Clarifies enforcement procedures for multiple failing REAC inspections.

Sets forth inspection process for voucher units.

Establishes flat rents for public housing and calculation for utility allowances for voucher tenants.













Other Provisions in Administration's 2015 Budget Proposal

RAD Component 1: removes cap on total units for Public Housing and Mod Rehab and extends program through September 30, 2018.

RAD Component 2: provides owner the choice to receive a PBRA or PBV contract for RAP, Rent Supp, or Mod Rehab properties and extends program to September 30, 2016.

Proposes legislative change to LIHPRHA to remove limitation on distributions.

> Option 1/ Chapter 15

Section 236 Decouplings H 2013-25



- New funding.
- Federal Register Notice January 2013; public comments due March 2013.
- Applications due September 3, 2013.
- Awards made December 2013.
- Mark up to market post rehab rents.
- Day 1 rents if perm loan amortizing.
- Requires waivers from HUD DC.
- Re-decoupling.
- Assignment of IRP; equity takeout.
- Early termination of IRP; eliminate LD; amend 236(e)(2) use agreement.
- HUD sent out draft HAP renewal guidebook as well as new chapters to HB 4350.




